Hi Rocky, Dean and Rich,



Regarding the late games at Borden that recently have gone

past reserved times, Rocky and I discussed and agreed to the following by phone this afternoon:

- 1. All games have a "**2** hour time limit" and no new inning can be started AFTER the 2 hours.
 - A new inning (if needed) *could* be started *up to one minute before* the 2 hour time limit.
- If a new inning was started right before the 2 hour time limit, then the game will be STOPPED after 2 hours + 15 minutes (= 135 minutes).
 - No exceptions whatsoever, regardless of the standings or scores after those 135 minutes.
 - If the last inning was not completed within those extra 15 minutes, then the scores/standing from the previous inning will stand.
 - Teams from the 6 PM game can use the field after 8:15 PM (after 135 minutes) if there are no reservations on the same field following their 6 PM reservation. (*Anybody can use our fields unreserved as long as the field is not reserved by somebody else or set up for a game later that day.*)
 - However, this depends on the scheduled punch-out time for our staff:
 - It's OK if other fields have later ending times and our staff has to be here anyway.
 - If our staff is scheduled to leave at 30 minutes past the 135 minute NOBF game (because there are no other late reservations), then the 6 PM NOBF game has to end at 8:15 PM after 135 minutes.
 - If the 6 PM teams have a Double Header, then they can play any time (including between 8:15 and 8:30 PM) as long as their second game officially starts **no later than** 8:30 PM and their final ending time is no later than 10:45 PM.
- 3. The *start time for 2 hour games starts at the RESERVED STARTING TIME* on the printed field permit issued by Borden Park to NOBF.
 - Even if the game started late for whatever reason (people not arriving on time, weather delays, etc.)
 - · Games can be started without umpires present
 - If NOBF internal schedules are different from Borden schedules (due to miscommunications or incorrect transfer of information), then the Borden schedule will override the NOBF schedule. Your NOBF existing reservations can always be viewed by anybody on our web site:

Example:

The 8:30 - 10:30 PM reserved time at Borden will unequivocally be STOPPED at 10:45 PM. Borden staff can then enter the field at 10:45 PM and remove bases so Borden staff can proceed with their closing responsibilities and punch out on their scheduled time.
